



Dear Exhibitor:

IMPORTANT! Please observe the following procedure to keep your arrival at the Keystone International Livestock Exposition smooth and uncomplicated.

1. Enter the grounds only through the North Gate. Please note the one-way traffic route around the building to the unloading areas.
2. Have all your health papers in the cab of your truck and ready to be checked at the gate area by a Bureau of Animal Health Technician. Animals are not permitted to enter the Pennsylvania Farm Show Complex & Expo Center before health papers are checked.
3. 840 ID requirements for cattle and swine will be enforced. Review the information on the website located on the Premium List page.
4. If you are exhibiting market barrows, you must turn in the enclosed certification form at weigh-in. **Also, a current PQA certificate must be on file with Show management prior to arrival.**
5. **PARKING** – In order to ensure adequate space for everyone, please adhere to the following guidelines:
 - a. **ALL LIVESTOCK AND HORSE TRAILERS MAY BE PARKED ON SITE AS SPACE PERMITS. OFF-SITE TRAILER PARKING IS ENCOURAGED. THE OFF-SITE LOT IS ONE MILE AWAY ON ELMERTON AVENUE. OVERNIGHT SECURITY WILL BE POSTED.**
 - b. The tie-out area is for tying cattle and not for parking.
 - c. Electrical hook-ups for campers are on a first come first serve basis. Electrical hook-ups are \$95.00 for the first night and \$40.00 each additional night. Contact Security upon arrival to be set-up. Security desk phone: (717) 231-6565.
 - d. See your department chairman if you have questions or special needs.
6. Beef cattle, goats, sheep, and swine may not be unloaded between the hours of 11:00 PM and 6:00 AM.

Straw and ground corncobs are the only bedding materials permitted for use by swine exhibitors. Sheep exhibitors may use any of the prior listed materials including shavings. **Initial bedding will not be furnished for goats, sheep, or swine.** All beef cattle will be bedded with shredded wood provided by the Exposition. This is the only bedding material permitted in the beef cattle area. No bedding will be provided for tie-outs – only straw is permitted.

A copy of your Certificate of Veterinary Inspection must accompany the animal(s) to the show. **All animals must have a 30 day Certificate of Veterinary Inspection.** Carefully read all health rules listed in the Premium List on the website.

Please note the vaccination recommendation for BVD, IBR, PI3, and BRSV protection for all cattle.

NOTE: RABIES VACCINATION WILL BE REQUIRED FOR THE 2024 KILE SHOW

All premiums are subject to change by the KILE Executive Committee dependent upon funding support.
